## Minutes of the Annual Meeting of Ashwellthorpe & Fundenhall Parish Council held on Monday 20<sup>th</sup> May 2019, 8:00pm in St Nicholas Church, Fundenhall

#### Members of the public

1) Election of Chair

Jacqueline Ives was elected unopposed, proposed by Nick De Spon, seconded by Ian Bishop, all in favour.

Nick De Spon was elected unopposed, proposed by Ian Bishop, seconded by Jerry Franey, all in favour.

- 6) Minutes of the Meeting held on  $16^{th}$  April 2019

These were agreed as a true record of proceedings with no amendments. All in favour.

- 7) To consider possible Co-Option onto the Parish Council None
- 8) Public Forum

(i)An update was given on the Wood Farm development which is currently ahead of schedule by two months. Discussion was had around the village green and whether it should be handed to Norfolk County Council who would adopt it. If NCC were to adopt it this would make it difficult for the parish council, as it would mean council would need to apply for planning permission on anything they should wish to do with the land. Advised to keep ownership of new village green.

Football pitch maintenance will cost around  $\pm 2,000$  a year but a sinking fund has been set at  $\pm 10,000$ .

Hedges may require cutting three times a year.

The roof on the new village hall will now be a pitched roof which means this has had to go through South Norfolk Planning as the original plan was to have a flat roof.

Another application has also gone through to change the bowling green to tennis courts. Overall the scheme should be completed within 24 months. Affordable homes have to be built first. Showhouse should be ready in four/five months. The scheme has received the

It was proposed that a meeting should be arranged with the Village Hall Committee to discuss the village hall. There is also the question as to what will become of the old village hall. This is currently a registered charity; will the new village hall also be a registered charity. It was suggested that the Clerk contact NALC for advice on management as this is a new area for the Parish Council. Council will also need to source a solicitor and NALC would be able to assist with this.

Vote to arrange a meeting specifically to cover village hall. Proposed by Jerry Franey - seconded by Ian Bishop – all in favour

(ii) Newly elected District Councillors were in attendance. Gerald Francis and Nigel Legg represent Mulbarton & Stoke Holy Cross ward. Both were congratulated on their election and council are looking forward to working with them.

#### 10) Matters arising from Minutes

(i)Purchase of second Speed Indicative Device (SID). Order has been placed and this machine will be erected near Wood Farm on the Street. The Sam machine will remain on New Road. Council propose to purchase another SID machine which can then remain near the Bridleway. Question was asked as to whether we could have 30mph painted on the road. Council to ask Cllr Spratt when next in attendance at Parish Council meeting. It was noted that the speeding figures appear to be lower at the centre point of the village.

(ii)New planters. One new planter required for Fundenhall. Chair to provide costs at next meeting.
