Minutes of the meeting of Ashwellthorpe & Fundenhall Parish Council held on Tuesday 17th December 2019, 7.30pm in Ashwellthorpe Village Hall

3)To approve the minutes of the meeting held on Tuesday 19th November 2019

Minutes were agreed as a true record of proceedings with no amendments.

4) Public Participation

- (i) Public in attendance, just to observe.
- (ii)Report from District Councillor.

Cllr Legg spoke of the proposed reduced speed limit on the B1113 Wreningham, from the crossroads to Mill Lane by NCC highways. Broadland and South Norfolk Council are currently discussing the refuse contract which for Broadland expires in 2022. South Norfolk run their collection service in house whilst Broadland out source. One consideration is to set up a company to do both areas which would reduce the cost. Government directives coming out soon on the collection of food waste. Grants still available up to £500. Bramble Bears are looking to apply for a grant.

5) Matters arising from previous minutes

(i) Fundenhall Sign. Clerk has spoken with the Compliance Officer at South Norfolk Council regarding the Community Infrastructure Levy money who confirmed this could be used to refurbish the Fundenhall Sign. So far only two quotes have been obtained.

6) Reports from Councillors

(i) Footpaths - Cllr Franey. Footpaths are very muddy due to the weather. Footpath sign needs to be reinstalled opposite the village hall on the path itself. It was suggested it would be better placed by the dog waste bin on the village hall site, but after discussion members felt it should be reinstalled in its original location on the path.

Proposed by Cllr Franey – seconded by Cllr De Spon – all in favour.

(ii) Village Hall – Cllr De Spon. Bramble Bears will take on the village hall full time from September 2020. Cllr Franey asked if he could see the business plan. The rent has been agreed at £100.00 per

month for the first 6 months after this it will rise to £150.00 and then after a year it will be £250.00 per month. Parish Council has to have a representative as a Trustee.

- (iii) Village maintenance Cllr Eastwood reported that the noticeboard outside the village hall, the doors have been adjusted to enable them to be unlocked without force. Chair and Clerk advised that there was still an issue with these last week. Cllr Eastwood will speak to Jaydee Gardens.
- (iv) Community Speed watch Cllr Bishop advised that this will recommence in January 2020. Would like some more people to join as volunteers. Two people stated they would like to join. Cllr Bishop has also asked for backup when he is not around to download data. Speed monitoring has shown there is a marked improvement in observing the limit, than what it was 4/5 years ago. The new Speed Indicative device will be installed facing entrance into the village from the B1113.

7) Parish Amenities Adoption Project.

Project Lead advised that they will be registering as a Charitable Incorporated Organisation (CIO). There will be a requirement for three councillors as Trustees for the CIO registration to be completed. The constitution has already been written. Cllr De Spon advised he has already put together a list of names of people who are willing to be Trustees within the village. Terms and Conditions for hirers of the hall have been drawn up. Risk assessments to be carried out nearer the time. Cllr Jary is talking to someone with regards to the pond and the risk assessment. Particular concern is the depth and type of fencing which should be erected.
