3) Declarations of interest

There were no declarations of interest.

4)To approve the minutes of the meeting held on Tuesday 21st July 2020

Chair also reminded councillors if there are any discrepancies within the minutes please could they advise the clerk prior to the meeting.

5) Matters arising from those minutes

i) Lower Wood. Chair spoke of numerous mail she had received from residents, and she had noted the contradictory responses from Norfolk Wildlife Trust to residents. Chair also spoke of response the parish council had received from Cllr Spratt and asked why he felt the need to copy Cllr Duffin in when he was no longer representing this area. Cllr Spratt apologised but he did not have new district councillors email addresses. He was sorry that the Chair was disappointed with his response and that a site meeting had taken place and the consensus was it cannot go any further and had the right to take the bridge down. Cllr Spratt spoke of the car which had been seen parked half on the pavement and half on the road, which was obstructing not only the farmer accessing his land but also pedestrians using the footpath. There is nothing saying people cannot park on the road but they cannot park on the pavement. Cllr Franey stated that prior to the agricultural barn being erected on the farmers land there had never been any issues. Suspect the barn will probably be used to garage agricultural equipment, hence more crucial to owner.

ii) War Memorial – Cllr Burridge has made contact with Perfitts Stonemasons of Diss and asked if they could inspect and report accordingly.

6) Reports from County and District Councillors.

i)County Cllr Spratt - advised there had been 15 cases of Covid-19 reported between 24.7.20 and 15.8.20. Testing by appointment only is carried out on a specially erected centre at Postwick Park and Ride. Resurfacing has been carried out on New Road and the white lines have been removed temporarily. Hedge has also been cut back on New Road to enable better visibility.

ii)Cllr Clifford-Jackson advised that people are becoming more confident in market towns but it has been difficult trying to put in place social distancing following government guidelines bearing in mind that these towns have old style narrow roads. New Code of Conduct is currently being drawn up and the Planning white paper is currently under review.

Cllr Legg spoke of the problems facing pharmacies with new developments and the need for better service.
