Housing with care flats as this helps get people into their own homes with a partnership with Norse, Broadland Council, SNDC and Saffron housing are making 10 homes available to allow people to get out of hospital and these would be administered by Norse care.

26 New Schools are looking to be built throughout Norfolk and a detailed list would be sent to the clerk soon.

There is a scheme that you can travel on local buses for a small charge of £2 Holt Hall ahs been sold now to Gresham School but as yet what they are looking to do with it is unknown.

The devolution deal around moving more power to Norfolk County Council has been approved in principle with the deal meaning £20 million pound a year over 30 years a total of £60 million and will be formally agreed at a cabinet meeting in the next couple of weeks

Finally 40 electric charging points will be made available in Norwich City Centre that are primarily to be used by people that do not have access to charging points at their home

Councillor Legg gave the following report

The hand over of Horizon House is still ongoing and everyone is still working from Thorpe Lodge. There is limited parking and the police are worried about the number of cars parked on Yarmouth Road causing issue for motorists but people are allowed to park there so no enforcement action can be taken. It was also reported that a deal for a grant from Salix to make Horizon House energy efficient had been submitted for £2.1 million

Village clusters is now moving forward and there is a recommendation for 15 homes to be built on the land off New Road, the consultation starts on 23/1 and the clerk will be attending the presentation on the 26/1 at Broadland Lodge in person.

There are concerns on public attendance at public meetings which is an offshoot from the covid issues. Councillor Legg comments that he had raised this and asked that both Broadland and South Norfolk Councils publish a list of such meetings allowing the public to see the meetings they need or would like to attend in future.
